Completion of Second Tranche of Share Placement and Cleansing Statement

Stavelly Minerals Limited ('Stavelly Minerals', ASX Code: SVY) is pleased to advise that settlement of the second tranche of the share placement (Placement) announced on 24 July 2020 has been completed. The Company has issued 13,666,667 ordinary fully paid shares at a subscription price of 60 cents each raising \$8.2 million before costs ('Second Tranche Share Placement'). The Second Tranche Share Placement was approved by shareholders at the General Meeting held on 31 August 2020.
